

## PHOTOGRAPHY LICENSE AGREEMENT

This Photography License Agreement (“**Agreement**”) is entered into by and between you (“**Licensee**”) and Costa Christ Media, LLC d/b/a Strictly natural light.® (“**Snl**”) (together, the “**Parties**”). In consideration of the following terms and conditions, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Parties agree as follows:

### SECTION 1 – DEFINITIONS

**1.01** “**Licensed Material**” means all still images or other visual, including visual representations generated optically, electronically, digitally, or by other means, and any prints, digital files, or other material licensed to Licensee by Snl under this Agreement.

**1.02** “**Invoice**” means the invoice(s) provided to Licensee by Snl, which may include the scope of services provided by Snl, the price for such services, including the license fee for the Licensed Material, and any limitations on the license in addition to those in this Agreement. The Invoice is incorporated into this Agreement, and any reference to the Agreement includes the Invoice.

### SECTION 2 – RIGHTS & RESTRICTIONS

**2.01** **License:** Unless stated otherwise in the Invoice, Snl grants Licensee a single perpetual, non-exclusive, non-sublicensable, and non-assignable worldwide right to use the Licensed Material identified in the Invoice for personal, commercial, and editorial use. An additional fee is required for use beyond this license. For clarity, this license is for the Licensee only. All others who wish to use the Licensed Material must purchase a separate license from Snl. A publication that wishes to use Licensed Material for an editorial, for example, must purchase a separate license from Snl.

**2.02** **Copyright:** Snl is the copyright owner of the Licensed Material and no ownership or copyright in any Licensed Material passes to Licensee under this Agreement. Except as expressly stated in this Agreement, Snl grants Licensee no right or license, express or implied, to the Licensed Material.

**2.03** **Restrictions:** Licensed Material shall not: (a) be incorporated into any trademark; (b) be made available in any medium that allows or invites persons to download or extract the Licensed Material; or (c) used contrary to any restriction identified in the Invoice.

### SECTION 3 – OTHER MATTERS

**3.01** **Credit in Editorial Use:** If Licensed Material is used in an editorial manner, the credit line “Photo by Costa Christ” or “Photography by Costa Christ” must appear adjacent to the Licensed Material or in the format standard for the publication.

**3.02** **Deposits, Cancellations, & Overdue Invoices:** Deposits are non-refundable. If a photoshoot with a deposit is cancelled or rescheduled for any reason, including because of an occurrence beyond the Licensee’s control, the deposit will be held and applied as a credit toward a future photoshoot with Snl. Photoshoots may be cancelled or rescheduled without penalty up to 48 hours before the reserved date. Photoshoots cancelled or rescheduled within 48 hours of the reserved date will incur a 10% fee on the project total. If Licensee fails to pay the Invoice within the time specified in the Invoice, Snl may, in its sole discretion, revoke the license.

**3.03** **Releases:** Snl makes no warranties regarding underlying or third-party rights in the Licensed Material, including the use of names, people, trademarks, trade dress, or copyrighted works depicted in the Licensed Material. Any release required in connection with the Licensed Material is Licensee’s responsibility.

**3.04** **Limitation of Liability:** Except as otherwise stated in this Agreement, Snl makes no warranties, express or implied, regarding the Licensed Material, including, without limitation, any implied warranties of merchantability or fitness for a particular purpose. Snl shall not be liable to Licensee or any other person or entity for any general, punitive, special, indirect, consequential, or incidental damages, lost profits, or any other damages, expenses, or costs related to Licensee’s use of the Licensed Material.

**3.05** **Indemnification:** Licensee shall indemnify, defend, and hold harmless Snl, its parent, subsidiaries, and commonly owned or controlled affiliates, and their respective members, partners, officers, directors, and employees, from all damages, liability, and expenses (including reasonable attorneys’ fees, costs, and expert witness expenses), related to any actual or threatened lawsuit, claim, or other legal or administrative proceeding (including before the Copyright Claims Board), related to Licensee’s use of the Licensed Material.

**3.06** **Waiver:** No action of Snl other than express written waiver is a waiver of any provision of this Agreement. Delay by Snl in exercising a right under this Agreement is not a waiver of that right.

**3.07** **Entire Agreement:** This Agreement, including the Invoice, constitutes the sole and entire agreement between the Parties with respect to the license of Licensed Material. This Agreement may only be modified in a writing signed by the Parties.

**3.08** **Governing Law & Jurisdiction:** This Agreement shall be governed, construed, and enforced under Texas law without regard to conflicts of laws. The Parties submit to the exclusive and mandatory jurisdiction of the state and federal courts located in Dallas County, Texas with respect to any dispute related to this Agreement.
